By submitting your photo you release all rights of this photo to Showcase and California kisses and have agreed to all the terms listed here for the competition

**1) Entrants must submit a photograph in front of the official California kisses pull banner at any of our Australian or New Zealand Showcase Regionals, wearing the current California kisses wear, you can use your own photographic equipment IE iPhone for the picture**

**2) Entry fee to the competition is via the Showcase online store for \$45 AUD. You must email your purchase receipt with your photo.**

**3) COMPETITION ENTITY:** CALIFORNIA KISSES is the sponsor of California Kisses 2016 Model Search (the "Competition"). Showcase is the Australian Promoter of the event and does not have any part of the judging process

**4) ELIGIBILITY:** To be eligible to enter the Competition, (1) you must be female, (2) a minimum of 4 years of age and a maximum of 17 years of age. Age as at December 31st 2015 (3) you must be a legal resident of Australia (4) must be a participant of the Showcase regionals

Employees, representatives and agents of California Kisses and any family member of, or any person domiciled with Showcase or global dance tours, any of the foregoing are not eligible to participate in the Competition.

California Kisses reserves the right to disqualify any Entrant whose image is published during the course of the Competition in any media (publications, World Wide Web, television, etc.), that in California Kisses' sole discretion shall be deemed to compete with California Kisses, any and all California Kisses brand extensions, or the Competition.

#### **THE ENTRY PERIOD AND HOW TO ENTER:**

An Entrant or Entrant's legal guardian may submit her entry form and photographs using the procedures described below at any time during the period of Aug 1st 2015 until Nov 1st, 2015 at 5:00PM Sydney time (the "Entry Period"). Late entries shall be ineligible. Date of entry during the Entry

Period will not affect chances of being chosen. Only one entry per person will be accepted; all subsequent entries will be disregarded. All photos must be submitted to the official Showcase facebook page and/or website.

#### **Semi Finalists**

Semi finalist will be announced by November 5th and will be required to submit to Showcase direct a head shot photo no later than November 15th All photos must be at least 500 K in size. Entrants or legal guardian of Entrants must retain the original photographs, as Semi-Finalists may be required to submit the Submitted Photographs in greater resolution.

Semi finalists chosen will be required to be present at Jupiter's Casino on the Gold Coast at their own travel expense between January 11th till January 18th 2016 for final judging and any photo shoots that they could be part of if they are selected as a grand finalist.

If you are chosen as a finalist, No photographs taken prior to December 1, 2014, non-color photographs, or photographs containing more than one person will be eligible. No enhanced or altered photographs will be eligible. While Entrants may have assistance in entering data and uploading the photos, each Entrant must otherwise complete the entry form herself.

California Kisses reserves the right, at any stage of the Competition, to contact any Entrant or legal guardian of Entrant to request resubmission of one or more of the Submitted Photographs and/or, for Semi-Finalists, the Submitted Video (including, but not limited to, in a different format than originally provided), and/or to request that the Entrant submit additional photos and/or videos (the "Additional Materials"), in California Kisses's sole discretion.

**SELECTION:** Selection of Semi-Finalists: California Kisses will, in its sole discretion, select among the Entrants a group of Semi-Finalists based upon California Kisses's evaluation of the Entrants' attractiveness and photogenic qualities (60%) and the quality of the Submitted Photographs and the Additional Materials, if any (40%). Approximately twelve (12) Entrants will be chosen to be Semi Finalists during the Competition. Semi-Finalists will be contacted via e-mail or telephone.

In the event that a Semi-Finalist is determined to be ineligible, fails to comply with California Kisses' instructions, or withdraws from the Competition or if a claim is made that she does not own or control sufficient rights in the Submitted Materials to grant the requisite rights to California Kisses with respect to the Submitted Materials (as described below), California Kisses reserves the right to remove such person's photograph(s) and/or video from the Web Site and substitute another Entrant to replace such person. The selection of the Semi-Finalists shall be within the sole discretion of California Kisses, whose decisions shall be final, and shall be based on the criteria listed herein.

**Selection of Finalists:** In January 2016, all semi finalists will be required to be on the Gold Coast at Jupiter's Casino California Kisses in its sole discretion, from the Nationals at Jupiters there will be Five (5) of the Semi-Finalists to be Finalists based upon California Kisses' evaluation of the Semi-Finalists' attractiveness and photogenic qualities (60%) and the quality of the Submitted Materials, including questionnaire responses (40%).

Any Finalist or legal guardian of Finalist who does not respond timely to any correspondence, or who is unable to attend the photo and video shoot, will be disqualified, and another Semi-Finalist may be chosen to replace her. California Kisses will conduct one or more photo and video shoots of the Finalists using professional photographers and videographers, and California Kisses will exclusively own all the rights related thereto.

Finalists or legal guardian of Finalists may also be required to return additional documentation, affidavits or releases as may be required by California Kisses, and if such documentation is not received by the designated date or if the documentation submitted is deemed to be, in California Kisses' sole determination, incomplete, erroneous or misleading, such Finalist will be ineligible to participate in the remainder of the Competition.
